IAKS fee structure

Applicable as of 1st January 2026

With reference to Article 6, II. of the IAKS Rules, the following fee rates will apply to members as of 1st January 2026.

1. Annual membership fees

A) Individuals pay an annual fee of

B)	Organizations, federations, or institutions under public or private law from the public sector, science and sport pay an annual fee of	420.00 EUR

- C) Organizations under private law from the commercial sector pay an annual fee of 560.00 EUR
- D) Young professionals who are in their first three years of professional practice pay a reduced annual fee of 50% of the respective fee determined in paragraph A. The three-year period is determined by the date of issue of the young professional's diploma or similar document.
- E) Start-up companies who are in their first three years of company activity pay a reduced annual fee of 50% of the respective fee determined in paragraph B and C. The three-year period is determined by the company's entry date into the official company register. Newly founded companies that are a spin-off of an already existing company or group cannot be considered as start-up companies. The number of employees of a start-up company must not exceed more than 10 employees.
- F) Organizations under private law which already have their primary membership (paragraph B or C) in one country, and which apply for one or more secondary membership(s) in other countries related to their global organization structure, pay a secondary or more membership fees equivalent to the fee of an individual member.
- G) Honorary members and Honorary Presidents are free of charge.
- H) Individual persons in retirement may be released from the membership fee by decision of the Executive Board.
- I) Full-time students are members free of charge. A certificate of matriculation shall be provided unsolicitedly until 15 January of each calendar year.



2. Members in countries with a section

The General Meeting empowers the Executive Board to charge different fees for members in countries with a section in consultation with the section's executive board.

3. Members in economically less developed countries

The IAKS sees itself as a global network for sports facility development, regardless of the economic conditions in the various countries of the world. Membership should also be available to those from economically less developed countries who are interested in membership.

Members in countries classified by the World Bank as "Low income", "Lower middle income", "Middle income" or "Upper middle income" countries may therefore pay only 50% of the fee rates mentioned in "1. Membership fees". These countries are as follows (September 2025, World Bank):

4. Length of membership

Membership is annual. In case a new member joins the IAKS in the second half of the year, the Executive Board is empowered to reduce the annual membership fee by 50%.

Termination of membership is subject to the provisions given in Article 5 of the IAKS Rules.
